Sidewalks and Street Trees Council's Past Action and Direction

**Accomplished**: eliminated inefficient sidewalk subsidy program (saving \$1.5M/year)

June Council Direction: <u>simplify</u> process to remove street tree causing sidewalk defect AND <u>limit</u> City liability for sidewalk defects

**November Council Direction**: Clarify <u>details</u> of the proposed ordinances AND <u>conduct</u> public information campaign

- Public Comment at Council Meeting
- Overall feedback was the need for more clarity and to answer a variety of questions



### Sidewalks and Street Trees Council's Past Action and Direction

Variety of Questions:

#### **Street Trees**

- Definition of a Street Tree?
- Ownership of Street Trees?
- Are permits always required to remove a street tree?
- When can a street tree be removed?

#### Sidewalks

- Cost for City to repair sidewalks?
- When is sidewalk repair triggered? (offset dimensions)
- Who is responsible for curb/gutter, utility box, ADA ramp?
- What are the approved methods of sidewalk repair?
- When must sidewalk repair be completed?
- What will the City do if I don't repair my sidewalk? (lien process)
- Legality to change liability?
- Inequity (corner lot, high pedestrian activity, old trees)
- Landscape Maintenance Districts gift of public funds?
- Financial hardship?

Sidewalks and Street Trees Draft Sidewalk Ordinance

- Adjacent property owner maintain sidewalk area adjacent to front and side yard in good repair
- Adjacent property owner responsible for sidewalk liability adjacent to front and side yard
- City to maintain sidewalk adjacent to City property, along backing lots, and at pedestrian access ramps and medians



Sidewalks and Street Trees Draft Sidewalk Repair Program

- Existing Sidewalk Repair Handout
- Expanding handout to additional information, for example:
  - Who is responsible for curb/gutter, utility box, ADA ramp?
  - What are the approved methods of sidewalk repair?
  - When must sidewalk repair be completed?
  - What will the City do if I don't repair my sidewalk? (lien process)



Sidewalks and Street Trees Sidewalk Repair Standard Details

- Sidewalk Repair = Standard Detail ST-31
- Sidewalk Grinding/Slicing Repair = Standard Detail ST-32
- Sidewalk Repair Criteria = Standard Detail ST-33



### Sidewalks and Street Trees Draft Street Trees Ordinance

- Retains requirement of adjacent property owners to maintain street trees in front and side yards
- Retains City as street tree owner
- Defines Street Tree
- Adds ability to remove street tree if causing sidewalk damage unless root pruning or other control measures can help
- Allows City to maintain a street tree that is causing a hazard and charge the property owner if they refuse to complete the work
- Adds replanting requirements
- Adds fines for non-compliance
- Requires new or 50% valuation improved lots to irrigate existing adjacent landscape areas

### Sidewalks and Street Trees Draft Street Trees Replanting Policy

- Each street tree removed = 15-gallon replacement tree and \$100 to the Urban Forestry Fund
- If no suitable location to replant in right-of-way, then:
  - 1. Plant on a portion of the applicant's property visible from the adjacent public right-of-way; or
  - 2. Payment to the City's Urban Forestry Fund of \$200 in-lieu of each replacement tree
- Street Tree replacement recommendations from City Arborist
- Replacement tree shall be planted within 120 days of tree removal
- Four or more street trees on developed commercial, industrial, institutional, or mixed-use property to be referred to the Community Development Department for determination




Sidewalks and Street Trees Street Tree Standard Details

- Tree Planting Guide (Master Street Tree List) = Standard Detail L-18A
- Street Tree Planting Quantities and Clearances
  = Standard Detail L-3A
- Street Tree Planting = Standard Detail L-3B, C, D,E

### Sidewalks and Street Trees Hardship Policy

 A property owner may request financial hardship assistance if the annual family income is less than 80% the annual median income for Alameda County.

• The note is due and payable upon the sale or any other transfer of any interest of the property.

Persons in Family	Income Limits
1	\$56,300
2	\$64,350
3	\$72,400
4	\$80,400
5	\$86,850
6	\$93,300
7	\$99,700
8	\$106,150
